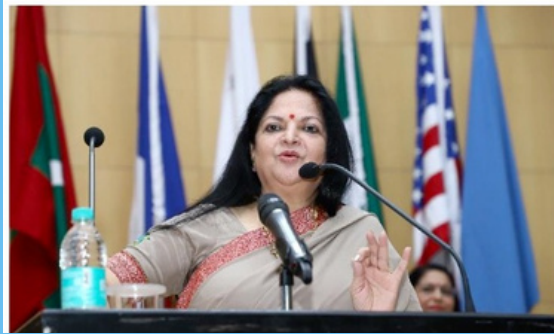

Agenda: Preventing the Proliferation of Hypersonic Weapons and Cyber Warfare Threats

6. Constituent Assembly of India (1948-49)

Agenda: Defining India's National Language Policy

Addressing linguistic diversity and deciding whether Hindi, English, or regional languages should dominate governance and education.

7. World Health Organization (WHO)

Agenda: Tackling the Rise of Antibiotic Resistance: A Global Public Health Emergency
